## ORDINANCE NO. 97-3, ORDINANCE ESTABLISHING RATES TO BE COLLECTED BY JENNINGS NORTHWEST REGIONAL UTILITIES:

WHEREAS, the Board of Trustees of Jennings Northwest Regional Utilities operates a wastewater treatment facility known as the Jennings Northwest Regional Utilities ("District"); and

WHEREAS, the District seeks to establish its initial rates in order to produce sufficient revenue to pay all the expenses incident to the operation of the District; to provide adequate funds to liquidate bonds or other evidences of indebtedness and provide sufficient revenue against the potential default of the same; and to provide adequate funds to be used as working capital, funds for making improvements, additions, extensions and replacements; and

WHEREAS, the District has the authority to establish initial rates for this purpose.

NOW, THEREFORE, be it ordained by the Board of Trustees of Jennings Northwest Regional Utilities, as follows:

Section 1. <u>Definitions</u>. For the purpose of this Ordinance, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

"Owners of Real Estate" means an individual, firm, company, association, corporation, governmental unit, or charitable or other nonprofit organization.

"Service Area" means any area in which the District is authorized to provide service.



Section 2. Rates: The monthly service rates for the District's water and sewer service are as follows:
